From the President

Just like the snowfall outdoors, January has started out with a flurry of activity for Friends Forever. The annual meeting was held on January 23rd with a review of the past year, election of new board members and officers, and a preview of 2013.

In 2012 we had more of both intakes and adoptions of companion animals, and the increase in revenue was (of course) offset by an increase in expenses. We also set up new business relationships to expand our reach and enjoyed a larger geographical representation of adopters.

2013 will be challenging, but will hopefully provide continued growth in both adoptions and revenue. One thing the new board is planning is to engage volunteers more deeply in our annual events such as Chili Day, the rummage sale, cookie walk, and so on. We will be looking for energetic and motivated volunteers to be event coordinators, hopefully allowing the board to concentrate on

larger fundraising programs including community and corporate fund drives. It would be great for event coordinators to be FFHS members, but it's not necessary. Interested? Just contact the shelter. We'd love your help!

We have a solid budget that will take us through the year but we are lean on reserves to cover unforeseen expenses. If fundraising efforts are successful at the corporate and community level, the building is in need of a new roof on the North side, the parking lot needs to be fixed and recoated, and there are plans to make the large dog kennel area more energy efficient.

Also at the shelter, HCC will be starting a wind study on our property to determine the effectiveness of wind turbine energy for our needs. If the results prove positive, grant applications could be filed as soon as this fall for the addition of a wind turbine in 2014.

My first two wishes for equipment this year would be a Gator or similar type UTV for maintenance of the park, and a newer van or conversion vehicle to replace the aging van we have now. On the human help side, I wish for enthusiastic new board members to round out our slate: we do have openings on the Board of Directors, and would be delighted to tell you more if you're interested. Please contact the shelter and a board officer will follow up with you.

As you can see from this issue, another wish came true with a new newsletter team - our thanks to these volunteers!

I hope to see you at Chili Day on March 6, and at many of our other events throughout the year - thank you for all you do to help Friends Forever!

Pet Pointers!

Friends share good ideas, and the Friends Forever newsletter is eager to hear yours! Do you have a tip about how to get your cat to take medication? A favorite game you invented to play with your pooch? The best formula ever for getting doggie smell off your sofa? We want to know about it! We may not always have room for every Pet Pointer, but we'll print as many as we can. Keep them short and send via email to newsletter editor Marilyn Smit at marilyn.smit@m45.com. To get started, here's a tip from her...

In dry, static-y winter air, stroking your pet can really get them charged up...literally! To reduce that bed-head look and minimize chances of that little electric shock when you then touch them on the nose, next time stroke them with a dryer sheet like Bounce. If fragrance doesn't bother them, you can use a scented version to get the added benefit of a dryer-

fresh-smelling dog! Be sure to do a little test first on just a small patch of fur to make sure Fido has no allergic reaction, and I wouldn't recommend this for cats (who can be particularly sensitive to cationics, the active chemicals in dryer sheets) or for dogs who lick themselves a lot. And of course, don't overdo their use. Bye-bye bed-head!

Sharing statistics

As manager of FFHS one of my many goals for 2013 is to increase adoption rates and save more animals.

To that end, I found the following information from the AVMA (American Veterinary Medicine Association) interesting. Among pet owners...

- 63.2% consider their pets as family members
- 35.8 % consider their pets as companions
- The remaining 1% consider their pets as property

So when one of our animals finds a forever home, they have wonderful odds of living a wonderful life!

Illinois overall, though, has room to grow in terms of pet ownership. The Top 10 dog-owning states in 2011 – where dogowning households numbered over 43% of the population – were Arkansas, New Mexico, Kentucky, Missouri, West Virginia, Mississippi, Alabama, Tennessee, Texas, and Oklahoma. The Bottom 10 – where dog-owning households were less than 33% – were Illinois, New Jersey, Minnesota, Maryland, percent, New Hampshire, Utah, Rhode Island, New York, Connecticut, and Massachusetts. The District of Columbia had far lower dog ownership than any state at only 13.1%.

For cats, the Top 10 states, all with over 34% of their households owning cats, were Vermont, Maine, Oregon, South Dakota, Washington, West Virginia, Kentucky, Indiana, and New Hampshire. The Bottom 10, with less than 27% cat ownership, were California, South Carolina, Rhode Island, Alabama, Florida, Georgia, Illinois, Louisiana, New Jersey, and Utah. The District of Columbia once again lagged far behind with cat ownership of only 11.6%.

This tells me that pets and politics aren't the best match and that warmer states seem to have more dog owners than cat owners (and vice versa), but it also tells me that part of our mission should be to share all of the benefits of pet ownership to more of our friends and family in our state. I'll include some of those points in future letters this year.

As one last stat supporting our adoption goals, the AVMA says that cat-owning households had a mean of 2.1 cats while dogowning households had a mean of 1.6 dogs. So if you know an animal lover whose pet needs a pal to bolster this statistic, send them our way...let's help move Illinois up on these lists in 2013!

Looking back...and forward!

For the first newsletter of the year I want to quickly summarize how 2012 ended, and then jump right into plans for 2013. At the beginning of 2012 we set several New Year's resolutions. We wanted to make sure our shelter kept running by not spending more than we made, not taking any money out of investments, and putting money back into the investments so they would grow. These steps were necessary to keep Friends Forever a viable business.

With your support and the extra fund-raising efforts throughout the year, we came very close to making these goals. In the past we have been losing \$10,000-20,000 a year. This year we only lost \$1,252. It isn't the same as making a profit, but it is definitely on the right track. The investments that we ended 2011 with were

not touched in 2012, so we accomplished that goal. We weren't able to put any back into our portfolio but the stocks and bonds did well so we ended the year \$12,000 higher than in 2011. This means that we will be close to passing the Year and 1 Day test in this year's audit which is very good news.

In 2013, we need to continue to work toward not spending more than we make so we

won't need to dip into our investments. While it is important to finish the year without a loss, it is also important to have money on hand when bills come due throughout the year. Our day-to-day income vs. our expenses is called cash flow. Businesses track their cash flow very closely to ensure that they do not find themselves with temporary shortfalls. We need to start tracking this closer than we have in the past.

Tracking regular expenses is not hard as most bills are cyclical. They either occur weekly, monthly, quarterly or yearly. By looking at last year's bills, it is easy to know what expenses are

coming next week or next month. Predicting income is trickier because so many outside forces can influence it. For example, donations can be effected by the economy and the weather can effect adoptions and dog park usage. By comparing multiple years, income patterns do show up. In our case, donations are low in late January and into February. In March, April and May donations are strong and historically we have done well with fund raisers. July and August's donations are again low. September is better, and then there is low activity in October until mid-November at which point the holiday season starts and we do very well with donations of money and gifts. By tracking cash flow we will be better able to fine tune our fund-raising efforts to either fill in where our income is historically low or plan to have enough reserves built up to last through the slow times.

2012 was the year we stepped up our fundraising efforts to bring our income into line with our expenses while still keeping our expenses down. In 2013 we need to make enough to cover our expenses, keep our expenses down, and start fine-tuning our fund-raising efforts to create a more balanced daily cash flow. All of these initiatives are needed to give our Humane Society a firmer

financial footing. We made a good start in 2012 and we will do even more in 2013 to ensure we are able to help the companion animals in our care now and for many years to come.
